Cartridge's high porosity design prevents it from plugging before its absorption capacity is reached

Manufactured of durable polypropylene and has excellent chemical resistance

Includes wall mounting bracket and hardware for fast and easy installation

System is shipped fully assembled

System includes water pressure gauge

Equipped with a pressure relief button to relieve water pressure during cartridge changes

# **INSTALLATION TIPS**

Choose a mounting location suitable to support the full weight of the system when operating.

Install vertically so housings hang down.

Allow 2-1/2" (6.35 cm) clearance below the cartridge for easy cartridge replacement.

Make sure o-ring on housing is sufficiently lubricated.

Always screw on housings by hand; do not use a housing wrench.

Flush filter by running water through filter according to cartridge instructions.

# **OPERATION TIPS**

Change cartridges on a regular six (6) month preventative maintenance program.

Change cartridges when capacity is reached or when pressure decreases.

Always inspect o-ring; change and/or lubricate if necessary.

Clean housing with mild solution of detergent before inserting new cartridge.

Always flush the filter cartridge at time of installation and cartridge change.






