## INSTALLATION TIPS

- ◆ Choose a mounting location suitable to support the full weight of the system when operating.
- ◆ Never use a saddle valve for connection.
- ◆ Use 3/4" water line.
- ◆ Do not connect system to water-cooled condenser.
- ◆ Install vertically with cartridges hanging down and allow 2 1/2" (6.35 cm) clearance below the cartridge for easy cartridge replacement.
- ◆ Flush cartridges by running water through system for five (5) minutes at full flow.

## OPERATION TIPS

- ◆ Replace cartridge when flow rate becomes inconveniently slow or before rated capacity is reached. It is recommended to replace cartridge at least once a year.
- ◆ Change cartridges when capacity is reached or when pressure falls below 10 psi (0.7 bar).
- ◆ Always flush the filter cartridge at time of installation and cartridge change.
- ◆ Inspect Pentair Everpure EC210 cartridge periodically to determine dirt load.
- ◆ Replace EC210 cartridge when dirt has penetrated through to the inner core of the cartridge.

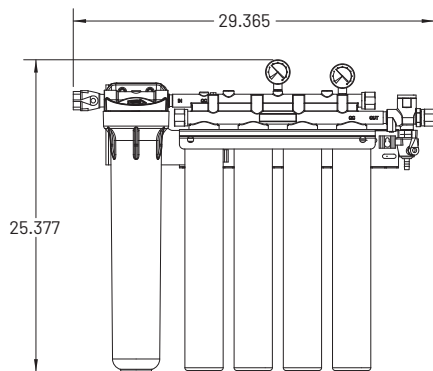
