- ◆ Refer to Installation, Operation & Maintenance Manual for cartridge flushing and startup.

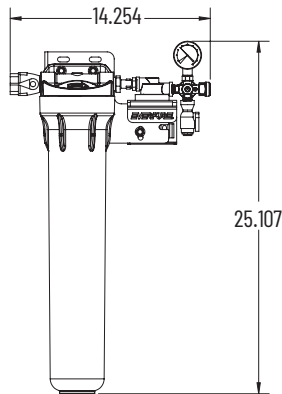
OPERATION TIPS

- ◆ Change cartridges when capacity is reached or when pressure decreases.
