## SYSTEM DESCRIPTION

Leveraging proprietary technology, the **EZ-RO 200/5G** system uses Reverse Osmosis (RO) to reduce Total Dissolved Solids (TDS); it provides up to 200 gal/day (757 L/day)\* and includes a five-gallon (18.9 L) hydropneumatic tank. Ideal for applications where RO is necessary to meet manufacturer's warranty requirements†.

## INSTALLATION TIPS

- ◆ Feed water connection to system—should be COLD only. Tempered water up to 80°F (26.6°C) can be used.
- ◆ Do not exceed system specifications for temperature and pressure.
- ◆ Provide a dedicated feed water supply connection of at least 3/8" inner diameter.
- ◆ For use with steam generation only. Do not use for condensate or wash water.
- ◆ Allow 3" clearance below system for filter cartridge removal and replacement.
- ◆ Detailed, illustrated installation guide is included with each system.

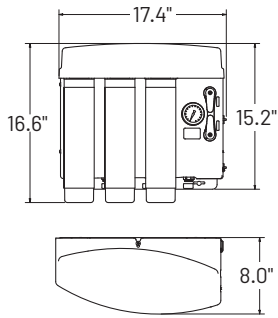

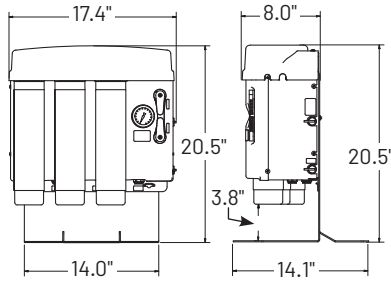

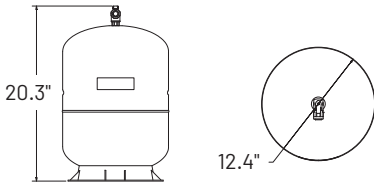
