MODEL DXP720: Sized for 14" x 18" trays.

MODEL DXP7201: Same as Model DXP720, except sized for 16" x 22" trays.

MODEL DXP722: Same as Model DXP720, except sized for 20" x 20" racks.

MODEL DXP721: Sized for two stacks of 14" x 18" trays or one stack of 18" x 26" pans.

MODEL DXP7211: Same as Model DXP721, except sized for two stacks of 15-1/4" x 20-1/2" trays.

MODEL DXP723: Same as Model DXP721, except sized to accept two stacks of 20" x 20" cup or glass racks.

OPTIONS

- DXPR - Rotating bumper
- DXPWB - Wheel brakes (set of 2)
- DXPY4 - Polyurethane 4" casters (set of 4)
- DXPY5 - Polyurethane 5" casters (set of 4)

FRAME AND PLATFORM

The frame is constructed of 1" O.D. 16 ga. stainless steel tubing, with 3/4" O.D. integrally welded cross rails for rigidity. The platform is constructed of 18 ga. stainless steel flanged down 1-1/4" for rigidity. The platform is set 12" above the floor. Tray units include a vertical tray stop.

CASTERS

The units are mounted on four 4" diameter heavy duty, swivel casters.
