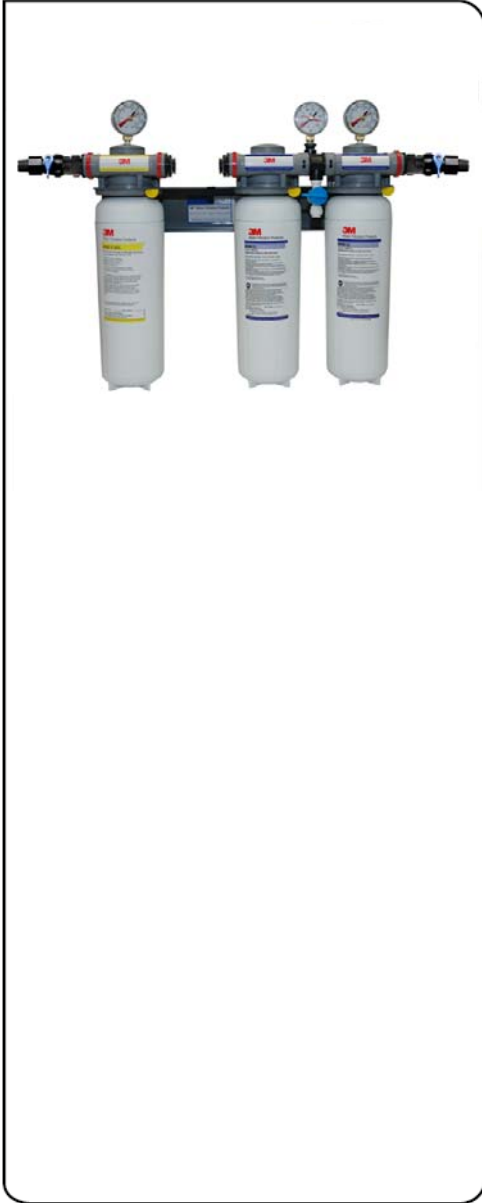

3M™ Water Filtration Products DIDF265-CL dual flow water filtration system helps provide consistent high quality water for the multiple applications of cold beverages and ice. Two separate streams exit the manifold. The first stream supplies cold beverage equipment and the second stream supplies the ice machine.

- The stream to the cold beverage equipment combines chloramines, sediment, chlorine taste and odor reduction.
- The stream to the ice machine reduces sediment and particulates. Chloramines and/or chlorine are not reduced from this stream to preserve their disinfectant properties. Scale inhibition media is added to reduce the hard scale effects of calcium and magnesium ions.

PRODUCT BENEFITS

- One system for dedicated ice and cold beverage applications that simultaneously supplies high quality water for beverage dispensers and ice machines.
- A dedicated non-carbon containing cartridge reduces sediment and particulates while adding a scale inhibition medium for ice machines. The inlet water's chlorine/chloramines content is unaffected for the reduction of biofilm in the ice machine.
- Sanitary Quick Change (SOC) encapsulated cartridge design allows for fast and easy cartridge change-outs with a 1/4 turn.
- 3/4" FNPT horizontal inlet and outlet ports allow direct or easily adaptable connections to existing plumbing lines.
- Manifold includes outlet check valves and vent valve.

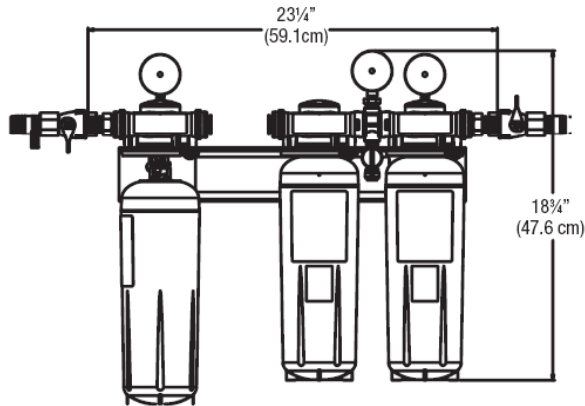
SPECIFICATIONS

- System includes a three cartridge dual outlet port manifold with built-in inlet and outlet pressure gauges, inlet water shut-off valve, outlet check valve, mounting brackets and the cartridge filters.
- Inlet and outlet plumbing connections are 3/4" FNPT.
- Filter cartridges are o-ring seal type.
- System maximum operating pressure of 125 psi (862 kPa) and operating temperature of 100°F (37.8°C).
- Beverage filter cartridges incorporate a carbon block filtration medium. Ice filter cartridge includes a scale inhibition medium.
- System materials are NSF Standard 42 and/or FDA CFR-21 compliant.
- Cartridges are sanitary in design, requiring no contact with the filter media during cartridge change-out.
- Filter cartridges require no pre-activation.
- NSF Performance Data Sheet (PDS) is included for the replacement filter.

IMPORTANT: INSTALLATION TIPS

These installation tips are for informational purposes only and are not intended to be used as actual installation instructions. **CAUTION: To reduce the risk associated with property damage due to water leakage:**

- **Read and follow** Use Instructions before installation and use of this system.
- Installation and use **MUST** comply with all state and local plumbing codes.
- **Protect from freezing**, remove filter cartridge when temperatures are expected to drop below 40°F (4.4°C).
- **Do not install on hot water supply lines.** The maximum operating water temperature of this filter system is 100°F (37.8°C).
- **Do not install** if water pressure exceeds 125 psi (862 kPa). If your water pressure exceeds 80 psi (552 kPa), you must install a pressure limiting valve. Contact a plumbing professional if you are uncertain how to check your water pressure.
- **Do not install** where water hammer conditions may occur. If water hammer conditions exist you must install a water hammer arrester. Contact a plumbing professional if you are uncertain how to check for this condition.
- The disposable filter cartridge **MUST** be replaced every 12 months, at the rated capacity or sooner if a noticeable reduction in flow rate occurs.
